



ORDER CREATING A PUBLIC INLAND LAKE PROTECTION AND REHABILITATION DISTRICT FOR GREATER WHITEWATER LAKE PURSUANT TO WISCONSIN STATUTE SECTION 33.26

The Walworth County Board of Supervisors having considered all of the objections to the Petition for the creation of a Public Inland Lake Protection and Rehabilitation District for Greater Whitewater Lake, Walworth County, Wisconsin, and being satisfied that the Petition was signed by the requisite owners of property as provided in Section 33.25 of the Wisconsin Statutes, the Walworth County Board of Supervisors does declare its findings as follows:

- 1. The proposed Public Inland Lake Protection and Rehabilitation District for Greater Whitewater Lake, Walworth County, Wisconsin, is necessary.
- 2. Public health, comfort, convenience, necessity or public welfare will be promoted by the establishment of a Public Inland Lake Protection and Rehabilitation District for Greater Whitewater Lake.
- 3. The property to be included in the District will be benefited by the establishment thereof.
- 4. Formation of the proposed District will not cause or contribute to long range environmental pollution as defined in Section 144.01(3) of the Wisconsin Statutes.

And based upon these findings, the Walworth County Board of Supervisors does establish a Public Inland Lake Protection and Rehabilitation District for Greater Whitewater Lake, Walworth County, Wisconsin, and does name such District "Whitewater Lake Management District" and does declare the District organized and does establish the boundaries of the Whitewater Lake Management District as the boundaries shown in the attached map and legal description.



In the course of a final review of this petition to the Walworth County Board of Supervisors, however, the Committee has discovered a few identifiable omissions and/or errors in the tax keys included in the map drawn by Messrs. Kolb and Jones. In order to make the legal description of properties within the proposed District correspond to that shown in white on the reduced map, it is necessary to modify the legal description as follows:

- a) Include within the proposed District,



PETITION FOR THE CREATION OF A PUBLIC INLAND LAKE PROTECTION AND REHABILITATION DISTRICT FOR GREATER WHITEWATER LAKE, WALWORTH COUNTY, WISCONSIN, PURSUANT TO WISCONSIN STATUTE SECTION 33.25 STATUTES OF 1983-1984

TO: WALWORTH COUNTY BOARD OF SUPERVISORS

We, the undersigned, constituting fifty-one (51) per cent of the landowners or the owners of fifty-one (51) percent of the land within the proposed district, do petition the Walworth County Board of Supervisors to create, pursuant to the authority granted to such Board, a public inland lake protection and rehabilitation district as defined and regulated pursuant to Chapter 33 of the Wisconsin Statutes.

In support of such petition, we do show the Walworth County Board of Supervisors as follows:

- 1. The proposed name of the district is Whitewater Lake Management District .
- The necessity for the proposed district is that the Whitewater-Rice Lake area represents a substantial recreational and financial asset. In the nearly 40 years since Whitewater Lake was formed by damming, no overall realistic working system for long-term management of the Whitewater-Rice Lake area has been developed. Whitewater Lake consists of approximately six hundred (600) acres of shoreline largely developed with residences on somewhat small lots with public usage of a state recreational area located on such lakes of approximately 70,000 persons per year. Whitewater Lake is not fed by streams and does not have a major outside pollution source and, as such, the quality of the lake is largely determined by events within the local watershed, which can be influenced by local control. It is necessary to research and gather data with respect to Whitewater Lake-Rice Lake area and related shorelands and to plan lake rehabilitation projects and to carry out lake protection and rehabilitation It is further necessary to identify and define present and anticipated problems of Whitewater-Rice Lake and to implement various remedial measures to deal with the problems and undertake activities such as protection of fishery, maintenance of appropriate lake levels and control of aquatic weeds and reduction of sedimentation.
- 3. The public health, comfort, convenience, necessity and public welfare will be promoted by the establishment of the district and lands to be included will be benefited by such establishment.
- 4. The district will not contribute to long-term environmental pollution.
- 5. The lands to be included within the district as proposed are shown on the attached legal description incorporated herein by reference.

The Committee has interacted as closely as possible with Wisconsin's Department of Natural Resources during this period. An early indication of the advantages to be expected from a Lake Management District is contained in the attached copy of a letter from the DNR, indicating that it has included Whitewater Lake in a small group of Wisconsin lakes selected for a 10 year monitoring and analytical study.

RE: History and Summarization of Results

The Greater Whitewater Lake Property Owners Association (GWLPOA) has existed for many years. Membership is voluntary and its dues-paying members typically represent about 1/3 of the property owners around Whitewater/Rice Lakes for purposes of improving the recreational and social opportunities in this area.

At the May, 1984 GWLPOA meeting, there were expressions of concern lest Whitewater/Rice Lakes might also suffer the severe deterioration in water quality seen in some other lakes in southeast Wisconsin. A committee was appointed to study the advisability of forming a public inland lake protection and rehabilitation district as defined and regulated pursuant to Chapter 33 of the Wisconsin Statutes.

At the September, 1984 GWLPOA meeting, the study group recommended the formation of such a Lake Management District for Whitewater/Rice Lakes. The GWLPOA members present voted to accept this recommendation, and a new Committee was created and charged to carry through the steps necessary to bring the petition for creation of the Whitewater Lake Management District to the Walworth County Board of Supervisors. This Committee began work immediately and started to collect the necessary signatures of property owners at the GWLPOA meeting on June 1, 1985.

One year later, and with the assistance of a number of property owners within the proposed District, the Committee can report the following:

a) From the Walworth County Records, we count 1080 property owners within the proposed District.


b) We count 104 owners of undeveloped properties within the proposed District who could not be properly contacted for their supporting signatures. These owners reside at considerable distances from Whitewater/Rice Lakes and visit this area infrequently. Mail and/or telephone solicitations have usually proven to be inadequate and inordinately expensive.

c) Of the relevant property owners listed in the Walworth County Records, at least 10 are known to be deceased.

d) The signatures attached to this petition number 656 and represent the approval of 60.7% (of the total 1080) of the property owners for formation of the Whitewater Lake Management District. This is substantially more than the minimum of \$1% required by Chapter 33 of the Wisconsin statutes.

This letter is to inform you that your lake has been selected by the Department of Natural Resources to be included in the long term trends monitoring program. This monitoring program is part of the new Lake Management Program. Fifty lakes statewide have been selected by the Department to be included in this ten year program. Criteria which were considered to select your lake included amount of local interest in lake management, potential for changes to occur in the lake ecosystem, and amount of existing information for the lake. The interest in lake management of the group working to establish a Lake Management District for Whitewater Lake was an important factor in selecting the lake to be included in this monitoring program.

The monitoring program is a comprehensive approach to evaluate long term changes in the lake ecosystem. The components of the lake ecosystem which will be evaluated will include water chemistry, algae, aquatic macrophytes, zooplankton, macroinvertebrates and fisheries. Department staff will collect and evaluate this information. In addition to the information the Department will be collecting, it would be very helpful if someone on your lake could assist the monitoring program by collecting weekly lake levels and summer weekly secchi disc readings. The Department will provide the training and equipment necessary to collect this information.

Lake Management Program

Why

Lakes are important. Lakes are important to our citizens; two out of three use lakes each year. Lakes are important to our tourists. More non-resident fishing licenses (over 500,000) are sold in Wisconsin than in any other state. Altogether, about 4,000,000 people enjoy Wisconsin lakes each year.

But lakes are fragile public resources. Unless they are protected and managed, their useful life can be dramatically shortened by sedimentation, nutrient enrichment, contamination, and acidic precipitation.

For Whom

Conservation clubs, property owners associations, lake districts, municipal governments, or other community groups are eligible to participate. Some projects require the financial and legal support of a governmental body.

By Whom

Funds for this modest program were allocated by the 1985-86 Wisconsin Legislature to the Department of Natural Resources (DNR) from revenue generated by the fuel tax. A core of four lake management specialists in the Bureau of Water Resources Management will provide leadership and coordination for DNR personnel in other bureaus and in district offices.

What

Self-Help Monitoring
Volunteers from interested communities will be trained by district DNR personnel to measure water clarity. The measurements are made once a week with a simple white and black disc (Secchi) lowered into the water until it is no longer visible. Information will be recorded on data sheets provided by DNR; DNR will also provide permanent computer storage. An annual report will be prepared and

Diagnostic Studies
Fifty lakes will be monitored for ten years to determine statewide trends. In addition, Department staff will select a few lakes each year for special studies. Lakes with potential for preventive management will receive highest priority.

provided to the volunteers.

Demonstration Projects
The feasibility of innovative technology will be tested on several lakes. Selection will be based on potential for application to lakes with similar physical characteristics. Possible demonstrations include:

- biomanipulation—to promote algaeeating organisms
- artificial wetlands—to filter nutrient and sediment
- porous pavement—to reduce runoff from roadways
- lake home simulations—to document impact of homeowner practices.

The attached 5 page document (including map and signature sheet) is an exact copy of the petition circulated to property owners in request for their signatures supporting the proposed Whitewater Lake Management District. The map is a photographic reduction of a larger scale map of the Whitewater Lake Area drawn by Registered Professional Land Surveyor Harold H. Kolb in January, 1964 and updated by S. Jones in June, 1984. This latter map was used as the base for defining the proposed District because it was the only available, up-to-date, single-scale, map of the entire area of interest when this Committee began to operate in September, 1984.

The reduced 4-color map accurately portrays: in white, the areas of privately owned land to be included within the proposed District; in pale green, those portions of publicly owned park lands to be included within the proposed District; and, in dark green, those areas not included in the proposed District. This reduced map represents the Committee's primary display for acquainting property owners with the boundaries of the proposed Lake Management District.

In the course of a final review of this petition to the Walworth County Board of Supervisors, however, the Committee has discovered a few identifiable omissions and/or errors in the tax keys included in the map drawn by Messrs. Kolb and Jones. In order to make the legal description of properties within the proposed District correspond to that shown in white on the reduced map, it is necessary to modify the legal description as follows:

- a) Include within the proposed District,
 Lots 1-1 Certified Survey Map #702B
 Tax Key Parcel Nos. W-31-5, W-35-2D, W-35-9, W-35-25,
 W-35-54.
- b) Delete from the proposed District, Tax Key Parcel No. W-35-1B.

To assist the County Board in determining the authenticity of certain signatures in support of this petition, the Committee also offers the following explanation concerning a lake access area defined as Lot 1, THORNE HEIGHTS SUBDIVISION. This parcel is further subdivided into 25 parts. The owners of these latter parts are elgible to sign the petition to form a Lake District, but the Tax Keys whereby they are so identified do not necessarily lie within the boundaries of the proposed District.
